Directorate General of Foreign Trade, vide its Public Notice No. 31 dated 26/8/2015, hasamended Paragraph (7) of Appendix-6B of Appendices and AayatNiryat Forms of FTP. The amended Paragraph (7) of Appendix-6B of Appendices and AayatNiryat Forms of FTP is as under:-

"(7)Textiles: Activities pertaining to reprocessing of garments/ used clothing /secondary textiles materials / clipping/ rags/ industrial wipers/shoddy wool/ yarn/ blankets/ shawls and other recyclable textile materials will not be allowed under EOU schemes.

Provided that extension of Letter of Permission for an existing unit shall be decided by the Board."

Through this Public Notice, DGFT has incorporated an enabling provision in paragraph (7) of Appendix 6-B of Appendices and AayatNiryat Forms of FTP 2015-20 so as to enable the Board of Approval to consider and decide the cases for extension of Letter of Permission of existing EOUs.
