EPCES CIRCULAR NO. 330

We are happy to inform that now EPCES is authorized to issue Registration-Cum-Membership-Certificate to Export Oriented Units, vide DGFT Public Notice No. 27/2015-2020 dated 26.8.2019.

We would like to inform that DGFT, vide Public Notice No. 44 dated 5/11/2018 had authorized EPCES to issue RCMC for EOUs by amending Appendix 2T of Handbook of Procedures. However, Para 6.34(14) of Handbook of Procedure was not amended wherein Development Commissioners were authorized to function as Registering Authority for EOUs. EPCES took up this issue with DGFT and finally DGFT amended Para 6.34(14) of Handbook of Procedures vide Public Notice No. 27 dated 26.8.2019. Vide this Public Notice, consequential amendment is made in the powers of Development Commissioner to act as a registering Authority in view of EPCES being recognized as a registering authority for EOUs vide Public Notice No. 44/2015-20 dated 5/11/2018.

A copy of Public Notice No. 27 dated 26.8.2019 along with Public Notice No. 44/2015-2020 dated 5/11/2018, is attached along with for kind information of the members.

In case of spices, it would be mandatory for units to get themselves registered with Spices Board also”.</p>	<p>Registration –cum-Membership Certificate:</p> <p>“Function as a Registering Authority for EHTP/STP/BTP unit. A separate Registration- cum- Membership Certificate shall not be required in their case as provided for in Paragraph 2.55 of FTP”.</p>
