**P**lease refer to DGFT Trade Notice No. 30/2023-24, dated (Attached) October 19, 2023, regarding the submission of data to the RoDTEP Committee for the review of RoDTEP rates.

2. Following consultations with industry stakeholders, the Drawback Division has now finalized the data submission formats, as detailed in their letter dated October 12, 2023. The deadline for submitting the required information to the RoDTEP Committee, using the designated formats provided in Annexure B (Part 1 and Part 2), is November 30, 2023.

This data will be essential for updating the RoDTEP rates previously recommended by the RoDTEP Committee, even though the government has yet to officially notify these rates.
